Due to the dry hot summer, we were concerned about tall grass at the New York Avenue house across from the apartments as well as the tall grass on the corner of Howard and Sunrise and along Pennsylvania. While we were getting ready to cut it ourselves, the County did its job. One other concern we had in the Spring was the closing of Jim's Bridge due to the flood damage. As we were in the process of drafting a letter to encourage its swift re-opening, it was. We will be monitoring the repairs.
